

Resolution A.39 (II)

UNITED NATIONS JOINT STAFF PENSION FUND
The Assembly,

Having taken note of the Recommendations contained in A/RES/1561(XV) of the General Assembly of the United Nations at its fifteenth session; and

Recognizing the importance of maintaining a common system of conditions of service within the principal organizations of the Pension Fund,

Decides

1. That, as from 1 April 1961, contributions to the United Nations Joint Staff Pension Fund, in respect of participants and associate participants of the staff of the Inter-Governmental Maritime Consultative Organization, shall be based on a point midway between the net annual salary and the corresponding United Nations gross salary;
2. In the case of General Service personnel, the arrangements for pensionable remuneration, as defined in paragraph 1 above, shall include any language allowance; however, non-resident's allowance shall be added only at the rate actually paid;
3. In the case of professional and higher staff, adjustments to the pensionable remuneration as determined in paragraph 1 shall be made in the same way as for the staff of the United Nations, in order to take account of variations in the weighted average of the post adjustment classifications.

The Assembly,

Having regard to Resolution A.21 (II) adopted by the Assembly on 6 April 1961,

Resolves that the eight largest shipowning nations for the purposes of Article 28 of the Convention shall be the eight nations shown in the Annex to A.II/WP.1 as having the largest gross register tonnage, namely:

GREECE
ITALY
JAPAN
LIBERIA
NORWAY
UNITED KINGDOM
UNITED STATES
